Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015-Allotment of 3,08,000 Equity Shares pursuant to exercise of Warrants allotted on preferential basis

This is in furtherance to the intimation given by the Himadri Speciality Chemical Ltd (“Company”) on 14 May 2024 w.r.t. allotment of 1,08,17,000 (One Crore Eight Lakh Seventeen Thousand) warrants, each exchangeable into one equity share of face value of Re. 1/- each, (“**Warrants**”) at an issue price (“**Warrant Issue Price**”) of Rs. 316/- (Rupees Three Hundred Sixteen only) [including the warrant subscription price (Rs. 79/- per warrant) and the warrant exercise price (Rs. 237/- per warrant)] on preferential basis to 28 allottees (“**Warrant Holders**”), as per the list forming part of the said letter.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), this is to inform you that upon receipt of an amount aggregating to Rs. 7,29,96,000/- (Rupees Seven Crore Twenty-Nine Lakh Ninety-Six Thousand only) at the rate of Rs. 237/- (Rupees Two Hundred Thirty-Seven Only) per warrant, being 75% of the Warrant Issue Price (“**Warrant Exercise Price**”), and application form from 9 (Nine) warrant holder, as per the terms of issue of Warrants, the Share Issue & Allotment Committee of the Board of Directors of the Company vide circular resolution passed today i.e. on 13 August 2025, has considered and approved the allotment of 3,08,000 (Three Lakh Eight Thousand) Equity Shares of face value of Re. 1/- each, upon conversion of equal number of Warrants, as per the details given in ‘**Annexure-I**’.

Consequently, the issued and paid up capital of the Company stands increased to Rs. 49,41,57,499/- consisting of 49,41,57,499 equity shares of Re. 1/- each.

The new equity shares so allotted shall rank *pari-passu* with the existing equity shares of the Company.
