## **Purpose**

## Scope

This policy applies to all Himadri facilities, including manufacturing plants and corporate offices & subsidiaries. It covers employees, contract employees, value chain partners, and anyone affected by our business activities.

# **Organization and Responsibilities**

Himadri is dedicated to maintaining a competitive and ethical marketplace. We commit to adhering to all applicable competition laws and regulations and conducting business with integrity, fairness and respect for our competitors. We are committed to avoiding any practices that would unfairly distort competition or harm end users. All employees and partners are expected to uphold these ethical standards in every aspect of their work.

#### **Our Commitments**

- Achieve a 100% mitigation of reported anti-fair competitive practices complaints.
- Ensure 100% completion of training on fair competition practices for all employees on annual basis.
- Conduct annual internal audit to assess compliance with fair competition policy, with a goal of reducing non-compliance findings by 100% year over year
- All bidding processes will be conducted fairly & independently. No employee will be engage in or facilitate bid rigging in any form.
- Products will be priced fairly and in accordance with both local and international trade laws.
   Dumping practices will be strictly prohibited.
- Pricing will be set based on legitimate market factors and not with the intent to drive competitors out of market through predatory pricing
- We will prohibit any agreements or understandings to divide territories, markets or customers.
- All employees are strictly prohibited to indulge in Cartel like behaviour and conducting abuse of dominance.
- We will monitor compliance regularly, using both internal and external audits to ensure adherence
- Company will form a separate committee to investigate and take appropriate measures related
  to every reported anti-competitive incident. All stake holders are actively encouraged to report
  any deviation through multiple anonymous channels (Email, Hotline etc.)

#### Governance

This policy is governed by the Sustainability (ESG) Council of Himadri under the supervision of the Sustainability (ESG) Committee at the Board level.

### **Policy Review**

This policy will be reviewed once in three years and updated as necessary to reflect changes in laws, regulations and market conditions.
